#### **Beautification Project**

Kanawha City Elementary was built in 1953. It's considered an older school. It has not been updated in a very long time. The PTA voted to take on a year-long beautification project to make our school, well, more beautiful on the inside and out. Parent and teachers are volunteering on various Saturdays to paint our hallways, clean our gymnasium and stage area and redo our teachers' lounge. We're raising funds through



business partnerships and sponsorships and donations of money and labor from parents. It sounds like a lot of work, and it is, but the camaraderie with parents has been priceless. And to see the children's and teachers faces when they walk in to an updated, vibrant school...that's what it's all about!

#### Art and Tech

Our PTA supports a separate program that focuses exclusively on art and technology. This is a very specialized program that has been available to our students for many years. Our current art projects range from recycled art to magazine strip projects to collage and ink pieces. In technology, our 2nd graders are now completing 3 projects in Word Art, Trading cards using PowerPoint, and a small group project using PowerPoint presentations with the kids' science unit topics.



#### **Fall Festival**

Our first big bash of the school year was our annual Fall Festival on October 16th. Over 500 people (families and community members) attend this event. This year, we provided lots of events including a game trailer, rock wall, tye dye shirts, pumpkin decorating, face painting, cake walk, sand art, football toss and basketball shoot, and many other activities. community to have fun and be involved in the life of our school. Each classroom also creates a pumpkin project to showcase at the festival. At the end of the festival, we auction the artwork to help raise funds for our school. The projects are more impressive every year.

# Attention: Treasurers (Audits and 990 Tax Filings)



Copies of the audit completed for your PTA for the 2014-2015 fiscal year should be sent to <u>treasurer@westvirginiapta.org</u> at your earliest convenience. Remember, this is one of the Standards of Affiliation items the state PTA needs from your unit!

It's also time to complete the 990 for your unit for the 2014-2015 fiscal year. If your PTA files a 990N (which most PTAs in West Virginia file), we have prepared a Step-by-Step Guide to help walk you through the process. Visit the website for more details. The 990 tax filing is due five months and fifteen days after the end of your fiscal year, so for most of our units that is November 15. If you aren't sure which tax form you are required to file and have questions, email Chris Wuest, WV PTA Treasurer at <u>treasurer@westvirginiapta.org</u> with the name of your local unit, and she will walk you through the process. On September 15, 2015, I participated in the first of six Federal Legislative Chair (FLC) Webinars. It was very informative. The National PTA legislative leaders talked about: the FLC Handbook, which is now electronic; the role of the FLC, which is to advocate to federal elected officials and shares issues with our state and local PTAs, and to get more PTA members to sign up for PTA Takes Action; and the Advocacy Toolkit on NPTA website. NPTA Legislative Committee then gave an update on some of the bills they're working on: ESEA/NCLB (Elementary and Secondary Education Act), JJDPA (Juvenile Justice & Delinquency Prevention Act), and HHFKA (Healthy Hunger-Free Kids Act). You can look to see what letters NPTA has signed on to support on their web-site, including Child Nutrition and Health, Early Childhood Learning, Education Technology and Student Data Privacy, etc.

On September 22, 2015, I attended the first meeting of Dr. Martirano's Stakeholder Advisory Group, with the West Virginia State Superintendent of Schools. The purpose of the meeting was for us to learn more about Dr. Martirano's "One Voice, One Focus" vision for West Virginia schools, as well as for us to provide input in how we can work together to improve public education in our state. Representatives from the military, NAACP, teacher and service personnel unions, lawyers, the realtor's association, higher education, and many other business leaders were in attendance. Dr. Martirano began the meeting by going through his vision and goals, pillars and priorities. He wanted to set a foundation. Then he distributed a draft copy of his strategic plan, which he went through in some detail. He asked for our input on the Strategic Plan, looking for omissions, adding measurable goals, etc. This group will be meeting quarterly to forward the work begun at this first meeting.

Here are some of his priorities/goals/objectives:

- 1. Students graduate from high school college/career-ready
  - a. Improve Grade 3 reading proficiency
  - b. Improve Grades 3-8 ELA (English/Language Arts) and Mathproficiency
  - c. Increase student success in rigorous courses leading to college credit or industryrecognized credentials
  - d. Improve Graduation Rate
- 2. Improve safe and supportive school environments: bullying, attendance, aggressive conduct
- 3. Improve workforce: increase salary, decrease use of substitutes, increase teacher credentials
- 4. Develop extensive and meaningful parent and community relationships, with effective communication with all stakeholders
- 5. Implement and expand data management systems and teacher evaluation systems

It was developed in 1969 by Colorado's PTA President Mary Lou Anderson to encourage students to explore their talents and express themselves. Since then, the Reflections Program has inspired millions of students to reflect on a specific theme and create original artwork.

Each year, students in Grades Pre-K through 12 are recognized for bringing the theme to life through dance choreography, film production, literature, music composition, photography and visual arts. In 2012, the Special Artist Division emerged as an optional division for students whose physical, cognitive, or mental health challenges meet ADA guidelines.

#### National PTA and Bayer USA Foundation Team Up to Engage Families in STEM Education

Collaboration will focus on filling a gap inSTEM education, increasing access to STEM experiences for all students and inspiring the next generation of STEM professionals

National PTA and Bayer USA Foundation have teamed up to launch a national effort to engage families in science, technology, engineering and math (STEM) education. Through the effort, National PTA and Bayer will deliver 100,000 STEM experiences over the next three years that engage entire families in hands-on activities—both in schools and at home. The goal is to fill a critical gap in STEM education, increase access to STEM experiences for all students and inspire the next generation of STEM professionals.

National PTA and Bayer's collaboration answers President Barack Obama's call to improve STEM education. Their efforts were announced in conjunction with the White House Astronomy Night.

"Decades of research show the critical role families play in children's success and achievement—no matter a family's socioeconomic background. Research also demonstrates that parents and guardians are the most influential in guiding in a child's educational and career decisions," said Laura Bay, president of National PTA. "Family engagement is essential to strengthen STEM education and help all children realize their fullest potential."

"For 20 years, Bayer has provided high-quality, meaningful STEM experiences to children through its 'Making Science Make Sense<sup>®</sup>' program," added Nathan R. Monell, CAE, National PTA executive director. "We are excited to collaborate with Bayer to build on 'Making Science Make Sense,' as well as other STEM programs, by engaging entire families."

A recent survey commissioned by Bayer underscores the importance of family engagement to STEM education. Key findings from the survey include:

- Parents are most likely to say they, themselves, play the biggest role in stimulating their child's interest in science (46 percent), followed closely by teachers (44 percent).
- Nearly one-third (31 percent) of parents don't feel confident enough in their scientific knowledge to help their children engage in hands-on science activities.
- One-third (32 percent) of teachers say parent support or involvement at home would be most helpful in increasing hands-on science learning experiences.

Through a variety of activities—including events, grants and resources—Bayer, National PTA and local PTAs across the country will engage and empower families to support student success in STEM and inspire their children to pursue STEM careers. The effort will include a focus on increasing access to STEM experiences in urban areas, particularly among girls and under-represented youth.

In early 2016, National PTA and Bayer will convene a STEM Family Engagement Alliance of education and industry leaders to work together to enhance STEM education through family engagement.

#### Keeping the Arts Alive Johnson Elementary School PTA Reflections Art Program

As our education system has evolved over the years, the arts in schools has faded away to what used to be a daily class, to now where schools are barely fitting in one class per week. For others, there is no art at all because of tighter budgets. For these reasons, the PTA Reflections Art program has allowed students to thrive and explore their talents in the arts.



Johnson Elementary School in Bridgeport, WV has participated in the PTA Reflections Art Program for many years. They began their journey by encouraging their students to submit entries for inclusion in an evening Art Gallery during the month of January. As the years went on, they continued to improve every year and decided to make a change as to encourage more participation in this event. Beginning in 2014, they moved the entry date for this program to the month of October. "Since then, we went from 30 entries to an amazing 50 plus entries in 2015,"three year Johnson Elementary PTA Reflections Chair, Stacy Martin said. Mrs. Martin said, "I am thrilled with the participation this year. It was the right thing for our students to have this time for entry submission. We have also had students enter in more than one category which shows their passion for the arts."

Over the past two years, Mrs. Martin decided to have all entries judged before the evening of the Reflections Art Gallery. This judging panel consists of a small group of volunteers not associated with any of the entries with some having a background in an art related field. This has helped with making the art gallery more relaxed and focused on allowing everyone to walk around and enjoy viewing the entries. They also have a small reception in the gallery with light refreshments. Then the awards are announced by marking the winners with place or participant cards. Midway through the gallery, they conduct the Awards Ceremony where the students are recognized for their entries.



PTA President Jennifer Bell was very happy again this year with the event. "It has always been the goal of the Johnson Elementary School PTA to encourage and showcase the artistic talents of our students. The Reflections Art program has grown at our school since we started five years ago. Our first Art Gallery maybe had 10 entries but this year we had 55 pieces of art submitted. It was exciting to see the students submit more videos in film production this year! As technology changes the artistic mediums change with it", Mrs. Bell said.

### National PTA Board of Directors Adopts Position Statement on Student Data Privacy and Security

ALEXANDRIA, Va., (Oct. 28, 2015) — With the increasing use of technology and data in education, National PTA's board of directors adopted a new position statement on student data privacy and security during its October board meeting. The statement calls for the promotion of policies that maintain the confidentiality of student information and ensure families have appropriate notification and consent for what and how children's data is collected and used.

"Technology and data are powerful tools to improve teaching and learning, but at the same time, it is imperative that students' academic and personal information is protected," said Laura Bay, president of National PTA. "It is a top priority of National PTA to make certain that children's data is safeguarded and that families are informed and engaged in the process."

As outlined in the position statement, National PTA and its constituents are committed to promoting policies and procedures that:

- Require states, districts and schools to be transparent and engage with families on the privacy and protection of student data
- Allow for parents and families to retain the right to review, inspect and obtain copies of their children's education records or online profiles
- Require school districts and online service providers to effectively and appropriately handle data breaches, including procedures to notify students and families

National PTA also urges school districts to designate a privacy and security officer to ensure compliance with privacy law as well as coordinate professional development for teachers, principals and any school employee or official who handles student data.

The association believes that federal laws—including the Family Educational Rights and Privacy Act (FERPA) and Children's Online Privacy Protection Act (COPPA)—must be modernized to protect electronic student profiles and the collection of information gathered online. PTA calls for Congress to also address the growing use of online service providers to make sure there are adequate parameters around the collection, storage, security, dissemination and destruction of student data.

"Data is critical to assess learning, guide instruction to better meet the needs of students and measure how well a school is performing. State departments of education and local districts also collect and aggregate data to help guide policy decisions and plan budgets," added Shannon Sevier, vice president of advocacy for National PTA. "Guaranteeing the effective use of students' data to support educational outcomes while keeping this information protected remains paramount."

In addition to adopting the position statement, National PTA recently collaborated with the <u>Future of Privacy Forum</u> and <u>ConnectSafely</u> to develop a free, digital guide to help parents understand the laws that protect student data as well as students' and parents' rights under the laws.
